Warranty. The warranty period is one year (365) days and commences on the date of shipment. Equipment to be examined, replaced or repaired at Seller's facilities must be returned to Seller by Purchaser within the warranty period, transportation charges prepaid. This warranty gives you specific legal rights, and you may also have other rights which vary from state to state.
